### **COMMUNICATIONS**

#### **Policy Statement**

Effective communication is essential in fostering a positive and collaborative school community. At St Columba's, we value respectful, open, and timely communication between staff, parents, and students to support student learning, well-being, and engagement. This policy outlines our expectations and preferred methods of communication in alignment with Brisbane Catholic Education (BCE) guidelines.

#### **Principles of Communication**

All communication within our school community should reflect the values of respect, trust, and collaboration. We commit to:

- Communicating in a timely and professional manner.
- Using appropriate channels for different types of communication.
- Encouraging positive and respectful interactions.
- Ensuring clarity and consistency in messaging.
- Protecting privacy and confidentiality in all communications.

#### **Expectations for Communication**

- Communication between parents and staff should be respectful, professional, and focused on student well-being and learning.
- Parents and staff should allow reasonable time for responses. Staff will respond to emails or messages within two working days during school hours (8:00 am 4:00 pm, Monday to Friday).
- Urgent matters should be directed to the school office by phone rather than email.
- Parents should communicate constructively and with mutual respect, ensuring discussions remain positive and solutions focused.
- Staff are not expected to respond to emails outside of working hours, on weekends, or during school holidays.
- Social media platforms and personal messaging apps (e.g., WhatsApp, Facebook Messenger) are not appropriate channels for communication between parents and staff regarding school matters.

#### **Preferred Communication Methods**

To ensure clarity and efficiency, the following communication methods are encouraged:

- Parents and staff work together effectively to support student learning and well-being.
- Concerns are addressed in a timely and constructive manner.
- Miscommunication and misunderstandings are minimised.
- A positive school culture is maintained, where all interactions reflect our school values of respect, collaboration, and responsibility.

#### Addressing Concerns and Feedback

- Parents are encouraged to address concerns directly with their child's teacher first before escalating to school leadership.
- If further discussion is needed, an appointment can be made with the relevant leadership team member.
- The Principal and leadership team are available to support concerns that require further resolution.

By following this policy, we can ensure a strong, respectful, and collaborative relationship between parents, staff, and students, enhancing the learning environment at St Columba's Primary School.
